R. STEWART RANDALL

Physician

R. Stewart Randall, 76, a Washington family physician whose medical career spanned more than 50 years, died July 17 at Washington Hospital Center of complications following a stroke.

Dr. Randall was a lifelong resident of Washington. He graduated from Dunbar High School, Howard University and its medical school. He began an internship at Freedman's Hospital here, then during World War II served in the Army Medical Corps in France. He received a Bronze Star.

After the war, he returned here and opened a family medical practice, which continued until his death. In addition to his practice, he also had been an instructor in the Howard University medical school department of family practice and in its preceptorship program in primary and comprehensive care. He had worked part-time at the Union Medical Center obstetrics and gynecology clinic.

He was a fellow of the American Academy of Family Physicians, a life member of the Medical Society of the District of Columbia and a member of the D.C.

JAMES D. JACKSON

Zoo Police Commander

James D. Jackson, 60, commander of the National Zoological Park Police, died of a heart attack July 18 at Fort Washington Medical Center. He lived in Fort Washington.

He was a retired Air Force technical sergeant who served in the military for 20 years. He had been with the zoo police since 1974, starting as a patrol officer. He had been commanding officer since 1986.

Capt. Jackson was a native of Washington and a graduate of Phelps Vocational High School.

His Air Force assignments included bases in Germany, England and in Vietnam, during the war there, as well as posts in the United States.

He was a football coach with the Oxon Hill Boys Club and manager of the Prophecy Band.

Survivors include his wife of 40 years, Gloria Juanita Russell Jackson of Fort Washington; six children, Anthony T. Jackson of Lanham, Aaron K. Jackson of Fort Washington, James D. Jackson Jr. of Camp Springs, Darryl V. Jackson of Hollywood, Md., Kevin Jackson of Forest Heights and Dorothea A. Robinson of Temple Hills; and 15 grandchildren.

HOWARD C. LOVEGROVE Jr.

Navy Commander

Howard Cleveland Lovegrove Jr., 72, a retired Navy commander who was a program control manager with Computer Sciences Corp. from 1967 to 1985, died on July 17 at Washington Hospital Center from injuries he received in a fall July 14 at his home in Woodbridge.

He retired from active Navy duty in a personnel assignment in the office of the secretary of defense in 1967, after four years at the Pentagon and 25 years in the Navy.

Cmdr. Lovegrove served as a pilot in the South Pacific during World War II and also flew during the Korean conflict.

He later commanded fighter squadrons in the Mediterranean and Pacific.

He was a native of Yonkers, N.Y., and a graduate of Syracuse University. He received a master's degree in financial management from George Washington University.

He had lived in the Washington area since 1963.

He was president of the administrative board at Cherrydale United Methodist Church in Arlington, where he also served as treasurer, conference delegate and a member of committees that included the pastor-parish relations committee. He was a volunteer at the Hermitage of Northern Virginia nursing center, where he conducted a weekly reading program.

His first wife, Helen Lovegrove, died in 1964. Survivors include his wife, Vista Lovegrove of Woodbridge; a son by his first marriage, William H. Lovegrove of Springfield; three stepchildren, Thomas Starbuck of Frankfurt, Germany, Jerry Starbuck of Laurel, Linda Starbuck-Schlotthober of Columbia; a sister, Helen Kelley of Bloomfield, N.Y.; two half brothers, Kenneth S. Landon of Monument, Colo., and George Landon of Clifton; and 11 grandchildren. A daughter, Linda Crary, died in 1974.

WILLIAM PEI WEI TSOW

China Consultant

William Pei Wei Tsow, 63, an independent consultant on Chinese politics, culture and linguistics, died of cancer July 17 at his home in McLean.

Mr. Tsow was born in Shanghai. He attended Fu-tan University in China and the University of Hong Kong, then in 1954 immigrated to the United States. He graduated from Franklin and Marshall College in Lancaster, Pa., and had done graduate study at Johns Hopkins University's School of Advanced International Studies in Washington. He worked for Morgan Guaranty Trust in New York and for an investments firm in San Francisco before settling in the Washington area in 1964.

In this area, he was an analyst at Research Analysis Corp. in McLean from 1964 to 1967. In the late 1960s and early 1970s, he taught at George Mason University, where he specialized in U.S. relations with the Far East. He was an account executive and investment broker with Johnston Lemon & Co. Inc. in 1978 and 1979. For about the last 10 years he had been a private consultant.

Survivors include his wife, Dorothy G. Tsow of McLean; two sons, David Anthony Tsow of Richmond and Alexander William Tsow of McLean; a brother, David P. Tsow of Toronto; and a sister, Fan Ming Tsow of London.

CLINTON O. FLINT JR.

Security Officer

Clinton Obiediah Flint Jr., 78, a retired security officer at General Research Co. in McLean, died July 16 at a hospital in Christiana, Del., after a heart attack.

Mr. Flint was born in Charlottesville. He moved to Washington in the 1930s and worked as an assistant buyer for the Hecht Co. before World War II, then served in the Coast Guard during the war. He returned to the Hecht Co. after the war. During the 1950s, he was a security guard at George Washington University Hospital. He was a security officer at General Research in the 1960s and in the 1970s, when he retired.

A former resident of Annandale, he moved to Charlottesville three years ago, then last year moved to Newark, Del.

His marriage to Hazel Flint ended in divorce. His second wife, Adelle Flint, died in 1981.

Survivors include two stepchildren, Wayne Cottrill of Annandale and Theresa Bullock of Denver; and a sister, Gladys F. O'Brien of Hockessin, Del.
